| Special Instruction (referred to in Idaho as Family Education)   | Developmental Specialist<br><br>(NOTE: For the Infant Toddler Program (through the Early Intervention Provider type) to bill Medicaid for the Children's Developmental Disability service of Family Education, the Infant Toddler Program Developmental Specialist must have a current B-3 Habilitative Intervention Certificate of completion) |
| Family Training, Counseling, and Home Visits   | Social Worker, Psychologist, Marriage and Family Therapist, or Professional Counselor.  |
| Health Services  | Physician, Physician Assistant, Nutritionist, Registered Nurse, or Licensed Practical Nurse.  |
| Medical Services (only for diagnostic or evaluation purposes)  | Physician, Physician Assistant, or Nurse Practitioner.  |

## Early Intervention Services and Qualified Providers

| Early Intervention Services   | Qualified Providers   |

| Nursing Services              | <p>Registered Nurse or Licensed Practical Nurse.</p> <p>The stability of the patient's environment, the patient's clinical state, and the predictability of the outcome determine the degree of direction and supervision that must be provided to the Licensed Practical Nurse.</p>  |
| Nutrition Services            | Registered Dietician.   |
| Occupational Therapy          | <p>Licensed Occupational Therapist or Certified Occupational Therapy Assistant.</p> <p>The Licensed Occupational Therapist shall be responsible for the supervision of the Certified Occupational Therapy Assistant.</p>  |
| Physical Therapy              | <p>Licensed Physical Therapist or Licensed Physical Therapist Assistant.</p> <p>A Licensed Physical Therapist shall supervise and be responsible for patient care given by Physical Therapist Assistants.</p>   |
| Psychological Services        | Psychologist or Clinician.  |
| Respite Care                  | Individual provider selected by a parent.   |
| Service Coordination Services | <p>Audiologist, Psychologist, Speech/Language Pathologist, Speech/Language Pathologist Aide/Assistant, Occupational Therapist, Certified Occupational Therapist, Developmental Therapist (fully qualified), Orientation and Mobility Specialist, Vision Specialist, Teacher for the Visually Impaired, Physical Therapist, Physical Therapist Assistant, Social Worker, Marriage and Family Therapist, Professional Counselor, Registered Dietician, Registered Nurse, Licensed Practical Nurse, Physician, or Nurse Practitioner.</p> <p>Under the supervision of a qualified Service Coordinator, paraprofessionals may be used to assist in the implementation of a Service Coordination Plan.</p> |

| Sign Language and Cued Language Service | Speech/Language Pathologist, Speech/Language Pathologist Aide/Assistant, or other professionals who have passed the Cued Language Transliterator National Certification Examination.   |
| Social Work Services                    | Social Worker.   |
| Speech/Language Pathology               | <p>Licensed Speech/Language Pathologist or Speech/Language Pathologist Aide/Assistant.</p> <p>It is the Licensed Speech/Language Pathologist's responsibility to design and implement a supervision system for the Speech/Language Pathologist Aide/Assistant that protects patient/client care and maintains the highest possible standards of quality.</p> |
| Transportation                          | Licensed driver.   |
| Vision Services                         | Orientation/Mobility Specialist, Vision Specialist, Teacher for the Visually Impaired, Ophthalmologists, or Optometrists.  |
