Housing	Sarah Spaulding	Chris Johnson brought to the table that when trying to help a participant apply for rental assistance it becomes difficult when there is no rental history for previous 2 years.	Sarah will talk with housing authorities to get some guidance on working around this required history on application and will include it in TM newsletter.
Benefits, services, self-direction	Sarah Spaulding	Being able to count the hospital stay days has made a difference.  Mary Jo Butler brought up concern about med administration being a barrier for people going home. Who can delegate? Can doctors? Nurses? What are Medicaid Rules on this? How could Medical Homes come into play?	Tammy Ray checked and Medicaid follows the Rules of the Idaho Board of Nursing IDAPA 23.01.01  Also found out there has been no update since Board of Nursing retreat.
