Participants qualify based on their diagnosis of conditions such as diabetes, asthma, or chronic mental health needs. This reimbursement is based on costs for staff time and other resources necessary to accomplish tasks for this level of care coordination. It will replace the existing case management fee for these participants, which ranges between \$2.50-\$3.50 per-member-per-month based on the participant's Medicaid enrollment and the provider's 46 hours per week of access. Total federal fiscal impact for IMHH is expected to be \$1,566,864 in FFY2013 and \$4,178,304 in FFY2014. This amount is expected to be offset by reductions in Healthy Connections payments of \$228,758 for quarters two through four of FFY2013 and \$781,747 in FFY2014 and a reduction in Pay for Performance expenditures of \$65,930 annually as outlined in the table below:
